## Information We Automatically Collect When You Visit Our Site

We monitor traffic on our site and measure which pages are visited in order to improve the Site and to provide information tailored to the needs and interests of our visitors. During your visit to our Site, we automatically collect certain information as described below:

### Cookies, Pixels and other Tracking Technologies:

When you visit our Site, a cookie, pixel or other tracking technology may be stored on your computer's hard drive. We use cookies and other similar tracking technologies to record information about visitors to our Site in order to recognize you as a return visitor the next time you visit, as well as support other operational needs for the Site to enhance and customize your experience. Cookies record certain technical information about you and your interactions with our Site, including the type of browser, operating system, and Internet service provider and allow us to tabulate the total number of visitors to our site, and may capture other information about your visit such as what website you were on just prior to visiting us (sometimes referred to as a referral site).

We classify our cookies into the following categories:

- **Strictly Necessary Cookies:** These cookies are necessary for core features of a site to operate properly.
- **Functional Cookies:** These cookies enable the website to provide enhanced functionality and personalization. They may be set by us or by third party providers whose services we have added to our pages.
- **Performance and Analytics Cookies:** These cookies are used to provide a better user experience on the site, such as measuring interactions with particular content or remembering settings. They also allow us to analyze site usage to evaluate and improve its performance. They are used to track certain metrics, such as site response times, and measure interactions with particular content.
- **Targeting and Advertising Cookies:** These cookies are used to show you ads that are more relevant to you. We may share this information with advertisers or use it to better understand your interests. For example, advertising cookies may be used to share data with advertisers so that the ads you see are more relevant to you, allow you to share certain pages with social networks, or allow you to post comments on our site.

If the cookie lifespan is not disclosed in the cookie settings, we use a default life span of thirteen (13) months, unless a shorter period is required by law.

**Log files:** We also collect certain technical information and store it in log files from your computer each time you request a page during a visit to our Site. This information may include your Internet Protocol (IP) address, your computer operating system, browser type, the addresses of pages you visit before and after visiting our Site, the date and time of your visit, and which pages you view during your visit to the Site.

**Clear Gifs:** The Site also uses a software technology called clear gifs (also known as web beacons or web bugs), which are tiny graphics that we use to record which pages are viewed by a Site visitor. In contrast to cookies, which are stored on a computer's hard drive, clear gifs are embedded invisibly on web pages as they are displayed and are about the size of the period at the end of this sentence. Clear gifs do not contain any personal information, and we do not use them to identify individuals.

**Third-Party Cookies** In addition to our own cookies, we work with various third-party companies and vendors to help us analyze website traffic and to optimize our Site and our marketing efforts on and off our Site. To opt out of certain third-party tracking, including for online advertising cookies, please see the Your Cookie Choices section below.

**Google Analytics** Google Analytics is a service provided by Google, Inc. ("Google"). Google Analytics uses cookies to help us analyze how users use our Site. The information generated by these cookies (including your truncated IP address) is transmitted to and stored by Google on servers in the United States. Google will use this information for the purpose of evaluating your, and other users', use of our website, compiling reports for us on website activity and providing other services relating to website activity and Internet usage. Please note that Google only receives your truncated IP address. This is sufficient for Google to identify (approximately) the country from which you are visiting our Site, but is not sufficient to identify you, or your computer or mobile device, individually.

**Google Ads and Google Remarketing** We may use the online advertising program Google Ads and the Google Remarketing technology, both operated by Google. For measuring conversion with Google Ads, a conversion tracking cookie is placed when a user clicks on an advertisement delivered by Google Ads. Conversion tracking cookies expire after 30 days and are not used for personal identification.
